
This is to inform you that the Monitoring program (39th quarterly program) in connection with "Monitoring of Environment Parameters and Implementation of Environmental Management Plan during Construction Period of 2×660 MW MSTPP" has been scheduled from January 24, 2024 to February 07, 2024.

1. The study team consists of specialists from different disciplines (relating to Water Quality, Air Quality, Noise quality, Ecosystem, Fisheries, Sundarbans Reserve Forest's floral biodiversity, implementation of an Environmental Management Plan, and Social survey). It is expected to monitor between the time above in and around the Plant site as well as in the Sundarbans Reserve Forest area. The activities of the team will be:
